Notice of Assignment for the Benefit of Creditors and
Instructions for Filing Proof of Claim Form

Dear Claimant of ChangeOne, Inc.:

Pursuant to a Deed Assignment for the Benefit of Creditors (the "Assignment") filed on June 5, 2008 with the Clerk of the Superior Court of Fulton County, Georgia, ChangeOne, Inc (the "Assignor") has assigned all of its assets to Hays Assignee Services I, LLC (the "Assignee" or "Trustee"). The Trustee's responsibilities under this assignment are to recover the assets identified in the Assignment Deed and determine claims for the purpose of using these funds to repay debts and liabilities to the extent possible.

The primary funds to be used by the Assignee to repay creditors will be from a sale of ChangeOne's Intellectual Property to Predictix, LLC. ChangeOne entered into an Asset Purchase Agreement on August 15, 2007 then amended on May 6, May 22, and June 2, 2008. The Agreement contains provisions for certain earn out revenue to be paid from the sale of the products. This income will be paid to the Trustee over a 10-year earn out period beginning in August 2009 and Trustee will in turn distribute funds to the creditors.

ChangeOne, Inc. signed an affidavit that, to its best knowledge and belief, is indebted to certain creditors that have been identified on Schedule A to the Deed of Assignment and filed with the court. A copy of the Deed of Assignment is available on the web site of the professionals retained by the Trustee at www.haysconsulting.net. The Assignor entered into the Assignment in a desire to develop a mechanism to repay these debts to the extent that funds are available. If funds are insufficient to pay such debts and liabilities in full, then the Trustee shall pay such debts and liabilities on a *pro rata* basis, subject to the payment of administrative expenses, secured claims, or any creditor priority provisions mandated by applicable law. The Trustee will distribute a Plan of Distribution before mailing checks to creditors.

A Proof of Claim is required to be filed to establish and validate a creditor's claim. The Proof of Claim form you file must provide sufficient documentation in order


to establish a valid claim. A Proof of Claim form is enclosed and may be reproduced for filing or downloaded from www.haysconsulting.net. The completed Proof of Claim form must be received by the Assignee at the above address **no later than August 31, 2008**.
