**ORDER
APPROVING INTERIM DISTRIBUTIONS**

On July 27, 2007, S. Gregory Hays, the court-appointed Receiver for Pinnacle Development Partners, LLC, filed a Motion for Approval of Interim Distributions Pending Final Resolution of All Disputed Claims. Pursuant to the terms of the Receiver's Plan for Claims Administration and Distribution of Proceeds (the "Plan"),¹ approved by the Court on April 18, 2007, the Receiver requested the authority to make interim distributions on Approved Claims pending the final resolution of all Disputed Claims.

¹ Capitalized terms in this Order shall mean and refer to those terms as defined and used in the Receiver's Plan.

Objections to the Receiver's motion were due to be filed on or before August 13, 2007. No objections were filed in response to the Receiver's motion.


Having considered the Receiver's motion and all exhibits in support thereof, and in accordance with the Plan, the Receiver's motion is hereby GRANTED. Accordingly,

IT IS HEREBY ORDERED that the Court grants the Receiver the authority to make interim distributions consistent with the terms of the Plan on all Approved Claims. Schedules of all currently Approved Investor Claims and Creditor Claims are attached to this Order. The Receiver shall have the authority to make interim distributions in such amounts and at such intervals as the Receiver determines to be prudent. Consistent with the terms of the Plan, however, no interim distribution will be made except after 10 days notice to the Securities and Exchange Commission, with opportunity for the SEC to object to the Court regarding such distribution.

IT IS FURTHER ORDERED that, pursuant to Section 2.7 of the Plan, the Receiver shall reserve funds sufficient to make appropriate distributions on Disputed Claims that are later categorized as Approved Claims. To that end, the Receiver shall submit to the Court at a later date all Disputed Claims that require resolution by the Court, as well as a list of all Approved Claims not included in the

schedules attached hereto. Within 30 days after the final determination of all Disputed Claims, the Receiver will file with the Court a final definitive schedule of all Approved Claims, Subordinated Claims and Disapproved Claims.
