PLEASE TAKE FURTHER NOTICE that your rights may be affected by the court's ruling on the Conversion Motion. You should read the Conversion Motion carefully and discuss it with your attorney, if you have one in the bankruptcy case. If you do not have an attorney, you may wish to consult on. **If you do not want the court to grant the relief sought in the Conversion Motion or if you want the court to consider your views, then you and/or your attorney must attend the hearing. You may also file a written response to the Conversion Motion with the Clerk, but you are not required to do so.** If you file a written response, you must attach a certificate stating when, how and on whom (including addresses) you served the response. Mail or deliver your response to that it is received by the Clerk no later than two business days before the Hearing, at the following address: Office of the Clerk, United States Bankruptcy Court, 75 Spring Street, SW, Atlanta, Georgia 30303.

You must also mail a copy of your response to the undersigned at the address stated below.
