NOTICE OF DISPOSITION REGARDING AIRCRAFT

S. Gregory Hays, the chapter 11 trustee (the "Trustee") appointed in the above captioned cases, hereby gives notice regarding the Trustee's disposition of that certain 1975 Beechcraft B58 Baron N7262R SN: TH-579 airplane (the "Aircraft") owned by the Debtors.

The Trustee obtained approval from this Court to sell the Aircraft free and clear of liens to any third party buyer selected by the Trustee so long as the price paid by the buyer nets at least \$90,000 to the Debtors' estates and the Omnibus Official Committee of Unsecured Creditors (the "Committee") approves the sale [ECF Docket No. 485].

The Trustee subsequently sold the Aircraft to HNP Aviation, LLC (the "Buyer") for a net sales price of \$90,000 on September 17, 2012. The Committee approved the sale. After \$900 worth of unanticipated repairs were made to the Aircraft, the Trustee received payment from the Buyer for \$89,100. A true and correct copy of the Aircraft Bill of Sale from the Trustee to the Buyer is attached as **Exhibit "A."**
