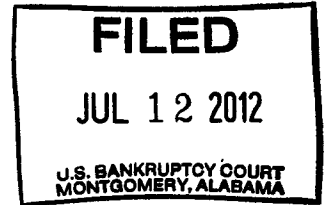

The fees of **\$509,743.75** and expenses of **\$29,393.91** filed by Max A. Moseley are outrageous and over the top fees.



