**NARRATIVE**

Pursuant to Sections 327, 328, 330, and 331 of the Bankruptcy Code and Rule 2014 of the Federal Rules of Bankruptcy Procedure, Christian & Small hereby moves this Court for an order awarding it reasonable compensation with respect to the bankruptcy cases of the above-captioned debtors (the "Debtors") for professional legal services rendered as counsel to S.

Gregory Hays, Chapter 11 Trustee (the "Trustee"), in the amount of \$55,090.00 with reimbursement for actual and necessary expenses incurred in the amount of \$2,719.53 for the period of January 1, 2013 through and including May 22, 2013 (the "Fee Period"). The Applicant further moves the Court for a final order approving all of the compensation and expenses awarded to Christian & Small in these cases. In support of its requests, the Applicant respectfully represents as follows:

### **Chapter 11 Filing**

1. On December 16, 2011 (the "Petition Date"), Small Loans, Inc., The Money Tree, Inc., The Money Tree of Louisiana, Inc., The Money Tree of Florida Inc., and The Money Tree of Georgia Inc. (collectively, the "Debtors") filed voluntary chapter 11 bankruptcy cases in this Court.

2. The Debtors' cases were procedurally consolidated by the Court's Order For Joint Administration dated January 5, 2012.

3. The Debtors are engaged in the business of making small, short-term loans to customers in the states of Alabama, Georgia, Louisiana, and Florida.

4. The Debtors have primarily obtained funding for their operations from the sale to private investors of unregistered subordinated debentures, and promissory notes.

5. Since the Petition Date, the Debtors have not obtained new financing.

6. On April 27, 2012, the Court granted the Omnibus Official Committee of Unsecured Creditors' (the "Committee") motion for the appointment of a chapter 11 trustee and S. Gregory Hays was appointed as the Trustee by Order dated April 30, 2012.

7. Since his appointment, the Trustee has commenced a diligent review and investigation of all assets of the Debtors' estates, and has liquidated all of the tangible assets of the Debtors.

### **Employment of Christian & Small**

8. On May 1, 2012, the Trustee, in the exercise of his business judgment and consistent with his fiduciary duties, determined to retain the law firm of Christian & Small to represent the Trustee and provide general bankruptcy legal services.

9. On May 8, 2012, the Trustee filed his Application to Employ Christian & Small as the Trustee's counsel. Christian & Small was employed under a general retainer to serve as counsel to the Trustee in connection with his administration of the estates of the Debtors. The Court entered an Order on June 5, 2012 authorizing the Trustee's employment of Christian & Small; therefore, the Applicant may be compensated on an hourly basis and reimbursed for the actual and necessary out-of-pocket expenses that the Applicant has incurred.

10. At all relevant times, Christian & Small has been a disinterested person as that term is defined in Section 101(14) of the Bankruptcy Code and has not represented or held any interest adverse to the Trustee.

11. All services for which compensation is requested by Christian & Small were performed for or on behalf of the Trustee and not on behalf of any other person. During the Fee Period, Christian & Small has received no payment and no promises for payment from any source for services rendered or to be rendered in any capacity whatsoever in connection with these cases. There is no agreement or understanding between Christian & Small and any other person, other than members of the firm, for the sharing of compensation to be received for services rendered in this case.

### **Summary of Services Rendered by Christian & Small**

12. The principal Christian & Small attorneys who have rendered professional services in this case during the Fee Period were Dan Sparks and Brad Hightower. Paralegal services were provided primarily by Gracie Gilbert.

13. Christian & Small has advised and represented the Trustee in connection with the Trustee's administration of the estates of the Debtors. This representation has included, among other things, legal services performed by Christian & Small regarding the Trustee's sale of certain assets owned by Best Buy Autos Bainbridge, Inc., a Georgia corporation for which The Money Tree of Georgia, Inc. is the sole shareholder, as well as the Trustee's sale of all the remaining assets owned by the Debtors to Western Shamrock Corporation. Christian & Small has further represented the Trustee with regard to the Trustee's omnibus objections to a large number of claims filed against the Debtors as well as the preparation and filing of a joint chapter 11 plan by the Trustee and the Committee that has been confirmed by the Court. A detailed itemization of all services and expenses is attached hereto as **Exhibit "A" and Exhibit "B."**

### **Summary of Services by Project**

14. Christian & Small was hired for only one project, which is to provide legal representation to the Trustee regarding the Trustee's administration of the Debtors' estates. All fees and expenses were incurred in this regard.

### **Disbursements**

15. Christian & Small has incurred out-of-pocket disbursements during the Fee Period in the amount of \$2,719.53. Christian & Small's list of out-of-pocket disbursements during the Fee Period contains categories of charges, including outside copying/photocopies, courier fees,

express carriers, postage, travel, ECF Access to Court Documents charges, and long distance calls.

### **Valuation of Services**

16. Attorneys and paralegals of Christian & Small have expended a total of 167.90 hours in connection with this case during the Fee Period. The normal hourly rates for work of this character were applied. The reasonable value of the services rendered by Christian & Small to the Trustee during the Fee Period is \$55,090.00.

17. In accordance with the factors enumerated in Section 330 of the Bankruptcy Code, the amount requested is fair and reasonable given (a) the complexity of these cases, (b) the time expended, (c) the nature and extent of the services rendered, (d) the value of services, and (e) the costs of comparable services other than in a case under this title. *See* 11 U.S.C. § 330(a)(3); *See also Norman v. Housing Authority of the City of Montgomery*, 836 F.2d 1292 (11<sup>th</sup> Cir. 1988), *Johnson v. Georgia Highway Express, Inc.*, 488 F.2d 714 (5<sup>th</sup> Cir. 1974).

18. Christian & Small seeks allowance and payment in the amount of \$55,090.00 for fees and \$2,719.53 for expenses for a total award of \$57,809.53.

19. Christian & Small further seeks a final order approving all of the compensation and expenses awarded to Applicant in these cases.

20. Finally, Christian & Small reserves the right to amend this application to the extent that it is required to defend or otherwise litigate any objections received regarding this application.

WHEREFORE, Christian & Small requests that allowance and payment be made to Applicant in the sum of \$55,090.00 as compensation for necessary professional services rendered to the Trustee for the Fee Period and the sum of \$2,719.53 for reimbursement of actual necessary

costs and expenses incurred during the Fee Period, for a total of \$57,809.53; that the Court enter a final order approving all of the compensation and expenses awarded to Christian & Small in these cases, and such other and further relief as this Court may deem just and proper.
