**AMENDMENT TO THIRD INTERIM AND FINAL APPLICATION FOR  
COMPENSATION AND REIMBURSEMENT OF EXPENSES SUBMITTED BY  
GREENBERG TRAURIG, LLP, ATTORNEYS FOR THE OMNIBUS OFFICIAL  
COMMITTEE OF UNSECURED CREDITORS**

Greenberg Traurig, LLP (the “Applicant” or “Greenberg”), counsel for the Omnibus Official Committee of Unsecured Creditors (the “Committee”) of Small Loans, Inc., et al., hereby submits this amendment to its third interim application for compensation and reimbursement of expenses for the period from October 1, 2012 through May 22, 2013 (the “Interim Period”) and for final approval of fees and expenses from January 27, 2012 through May 22, 2013 (the “Application”) [Docket No. 848], as follows:

1. The Application was filed on May 22, 2013. As an amendment to the Application, the Applicant hereby submits certain additional expenses from the Interim Period, totaling \$2,854.39, which were inadvertently not included in the Application. These expenses were incurred by the Applicant during the interim period relating to, among other things, the plan solicitation and balloting process. An invoice containing further detail for these amounts is attached hereto as Exhibit A. A supporting affidavit is attached hereto as Exhibit B.

**WHEREFORE, PREMISES CONSIDERED**, the Applicant respectfully requests that the Court (1) enter an order pursuant to Sections 330 and 331 of the Bankruptcy Code approving

the Application, as amended herein; (2) allow compensation for the Applicant in the amount of \$166,610.70 and approval of expenses in the total amount of \$19,409.43 for the Interim Period, (3) final approval of fees in the amount of and final approval of fees in the total amount of \$578,114.10 and approval of expenses in the total amount of \$35,907.87 for the Applicant; (4) that the Liquidating Trustee be authorized and directed to pay to Applicant any amounts that are awarded; and (5) grant such other, further, or additional relief as may be just and proper.
