#### DECLARATION OF RALPH S. FREEMAN

I, Ralph S. Freeman, do hereby declare under penalty of perjury and in accordance with 28 U.S.C. § 1746 that this declaration is made of my own personal knowledge, that I am competent to testify as to the matters stated herein, and that the following statements are all true and correct.

- 1. I am a principal and co-owner of Bray & Freeman, LLP, and a licensed private investigator by the State of Texas. Additionally, I am a certified fraud investigator and have been since 1995, and have been investigating and working in support of receivers for the Securities Exchange Commission and Federal Trade Commission since July of 2002. In this endeavor, I was hired by the counsel for the receiver in this action, by Clark Will of Quilling, Selander, Cummiskey & Lownds, P.C. The receiver in this matter is S. Gregory Hays (the "Receiver"), who is the duly appointed Receiver for the Defendants and Relief Defendants in the above captioned civil action (the "Correll Action"). Greg Thompson and TNT Office Supply, Inc. (together "Thompson") are named defendants in the Correll Action.
- 2. When the Correll Action was filed, I accompanied Mr. Will, and other attorneys with his firm, to San Antonio to begin investigating, locating, seizing, accounting, and ultimately liquidating the assets of Thompson in San Antonio. We commenced said actions on December 7, 2005. Since that time, I have worked with Mr. Will to locate, seize and liquidate Thompson's assets, as directed by the various orders of the Court in the Correll Action.
- 3. As a certified fraud examiner, I examined the records, books and accounts kept by Greg Thompson and TNT Office Supply, Inc. This activity was facilitated because Thompson utilized the services of a certified public accountant in San Antonio, Mr. John Sabatino. Mr. Sabatino had prepared form 1099's for the various investors, based upon information and documentation provided to him by Thompson.
- 4. Attached hereto as <u>Exhibit 1</u> and incorporated by reference herein for all purposes, is a true and correct copy of any analysis memorandum that I prepared in this case. Said memorandum was based upon my analysis of accounts, records and documentation that I

had assisted in the preparation of, with the exception of the data from Travis Correll's documents. Mr. Correll's information was supplied to me by Scott Askue, who also works for the Receiver in this action.

- 5. As is reflected in Exhibit 1, I have determined that the total of the ill gotten gain or benefit from the Horizon Establishment ponzi scheme to Greg Thompson, either directly or to his immediate family or entities controlled by him, was \$1,208,539.00. The Receiver, through the actions of me and Mr. Will, had collected and liquidated assets belonging to Thompson that totaled \$1,138, 080.33 as of the date of Exhibit 1. There was some discussion with Mr. Thompson's counsel, Mr. Scott Baker, to the extent that the Receiver was willing to conclude that no further action or disgorgement needed to be done or collected from Mr. Thompson, however, after initially seeming to indicate that such was agreeable, Mr. Baker has not responded to inquiries or correspondence.
- 6. Since I prepared the analysis at Exhibit 1, additional assets were identified and liquidated. Additionally, part of the assets collected by the Receiver from Thompson included Oil & Gas royalty and working interest revenue. Attached hereto as **Exhibit 2** and incorporated by reference herein for all purposes is an updated version of Exhibit D to Exhibit 1. As can be seen the amount of assets collected from Mr. Thompson now total \$1,167,629.37.
- 7. Based upon my over fifteen years experience as a certified fraud investigator, private investigator, and my review of the account documents and other information made available to me in this case, Greg Thompson profited from the ponzi scheme in this case in the amount of \$1,208,539.00. Based upon my personal knowledge of the investigation, location, collection and liquidation of Thompson's assets in this case, the Receiver, has collected

\$1,167,629.37, more or less, towards this amount, leaving a net ill gotten gain of \$40,909.70.

**Thompson Collected Funds** 

- 1. According to Sabatino, at Thompson's direction he adjusted the 1099's re: Greg Thompson, Dwight Johnson, and Robbie Gowdey (see exhibit A). Sabatino advised that Thompson directed him to amend his tax returns for 2003 and 2004. The result was refunds totaling \$123,472 to Thompson (see exhibit B). These funds were not tendered to the receiver.
- 2. The 1099 summary provided by Sabatino, addressing the time period of April 1, 2003 to September 30, 2005, indicates that Sandra Thompson was a Ponzi winner in the amount of \$169,750 (see exhibit C).

#### Summary:

- Records in Dallas indicate we have collected to date re: Thompson and TNT: \$1,138,080.33 (see exhibit D).
- Documents provided by Scott (see exhibit E) indicate a net gain to Thompson of \$915,317.

915,317 net gain

123,472 amended tax returns

169,750 Sandra Thompson Gains

\$1,208,539 total gain to Thompson et al.

The difference between funds collected and that gain is \$70,459 in Thompson's favor. We are hoping to collect an additional \$20,000 to 25,000 from Messrs. Cadwell and Bush re: Thompson's investment in One Smart Tool. There were also entries in Thompson's
