NOTICE OF HEARING ON MOTION FOR APPROVAL OF JOINT STIPULATION AND SETTLEMENT AGREEMENT AND AUTHORITY TO REJECT AN UNEXPIRED LEASE

NOTICE IS HEREBY GIVEN, pursuant to Fed. R. Bankr. P. 2002(a)(3), that S. Gregory Hays, Chapter 7 Trustee for the estate of Jova/Daniels/Busby, Inc.
