**ORDER GRANTING RECEIVER'S MOTION  
FOR AUTHORIZATION TO TRANSFER MANAGEMENT  
OF ACCOUNTS TO THE GEORGIA PORTS AUTHORITY**

This matter comes before the Court on the Receiver's Motion for Authorization to Return Accounts to the Georgia Ports Authority. Having read and considered the Receiver's Motion, and for good cause shown, the Receiver's Motion is **GRANTED**. Accordingly,

**IT IS HEREBY ORDERED** that:

1. The Georgia Ports Authority (the "GPA") shall pay the Receiver all fees owed to SJK from March 31, 2011 through June 30, 2011. The

amount of fees owed shall be determined by the Receiver and the GPA as soon as reasonably practicable after June 30, 2011.


2. Upon the payment of all fees owed to SJK, the Receiver is authorized to take such action as may be necessary to promptly transfer management and control of the GPA Accounts to the GPA.

4. The GPA shall be solely responsible for paying all fees owed to the following third-party managers of each of the GPA Accounts:

BNP Account Ending in 1045	SG Capital Management, LLC
GS Account Ending in 5487	Madison Street Partners, LLC
GS Account Ending in 7TDJ	Manalapan Oracle Advisers, LLC
GS Account Ending in 5851	Rivanna Capital LLC

5. Upon entry of this Order, the Receiver and Receiver Estate shall be fully released from any and all liability or responsibility related to the GPA Accounts, including liability or responsibility for the fees owed by GPA to the third-party managers.
