## NOTICE OF MOTION

NOTICE IS HEREBY GIVEN that on July 16, 2008, S. Gregory Hays ("Receiver"), the court-appointed Receiver for Albert E. Parish, Parish Economics, LLC, and Summerville Hard Assets, LLC (collectively the "Receiver Estate"), filed a motion ("the Motion") seeking approval of a settlement and compromise with Legare & Bailey, LLC, Daniel O. Legare, J. Mark Bailey, Gloria S. Legare, Melissa C. Legare, and Christina F. Bailey (the "Settling Parties"). A copy of the Motion, along with supporting papers, can be found on the Receiver's website, <a href="https://www.haysconsulting.net">www.haysconsulting.net</a>. You may also request a copy by contacting the undersigned counsel for the Receiver.

In sum, the settlement provides that Settling Parties will pay the Receiver \$952,000 (which includes 92.5% of Legare & Bailey, LLC's insurance coverage), and waive their right to receive payment on any claims. However, this settlement payment and waiver and the other terms of the settlement are expressly conditioned

permanently enjoining prosecution of any pending lawsuits and the filing of any third party claims or causes of action, including, but not limited to, claims by investors in and creditors of the Defendants in the Enforcement Action, against Legare & Bailey, LLC, Daniel O. Legare, Gloria S. Legare, Melissa C. Legare, J. Mark Bailey, Christina F. Bailey, their heirs, successors, agents or assigns arising out of or in any way connected with: (a) the investment-related activities of Parish, Parish Economics, LLC and/or Summerville Hard Assets, LLC or any affiliated "investment pool"; (b) professional services rendered by Legare & Bailey, LLC, J. Mark Bailey and/or Daniel O. Legare; and/or (c) any investment made by any person or entity in the investment pools that are the subject of the Enforcement Action.

Your rights may be affected by the Court's ruling on this Motion. If you object to or oppose the Motion, you must file a written objection with the Court no later than August 8, 2008, with a copy served on counsel for the Receiver:

In the event of any objection, the objecting party must also appear at the hearing on this matter before Judge Norton in the United States District Court for South Carolina, Charleston Division.
