ORDER AND NOTICE ESTABLISHING BAR DATE FOR FILING (A) MOTIONS SEEKING ALLOWANCE OF ADMINISTRATIVE EXPENSE CLAIMS AND (B) PROOFS OF CLAIM FOR POST-PETITION WAGES

TO: ALL CREDITORS AND PARTIES IN INTEREST WITH CLAIMS AGAINST THE DEBTOR FOR SUBJECT ADMINISTRATIVE EXPENSE CLAIMS (AS DESCRIBED HEREIN) OR CLAIMS FOR POST-PETITION WAGES.

PLEASE TAKE NOTICE that Neil C. Gordon (“Trustee”), the duly qualified and acting Chapter 7 Trustee in the above-captioned case, has filed a motion for Entry of Order Establishing Bar Date for Filing (a) Motions Seeking Allowance of Administrative Expense Claims and (b) Proofs of Claim for Post-Petition Wages (the “Motion”). Regardless of this Order and Notice, **if you have previously filed a proof of claim in this bankruptcy case you, DO NOT NEED TO FILE ANOTHER PROOF OF CLAIM.** This does not relate to proofs of claim except for post-petition wages.

Upon consideration of the representations contained in the Motion and the facts and circumstances of this case, the Court finds that it is appropriate that a bar order issue with respect to the filing of motions seeking the payment of a claim for administrative expenses, as defined in 11 U.S.C. § 503 against Debtor, **excluding (a) administrative expense claims previously allowed or denied by order of the Court; (b) administrative expense claims held by the duly appointed Trustee or the professionals retained by him in accordance with the Bankruptcy Code; and/or (c) claims for post-petition wages (the "Post-Petition Wages") held by the current and/or former employees of the Debtor** (the "Subject Administrative Expense Claims"). Accordingly, it is hereby

ORDERED AND ADJUDGED that March 31, 2013 (the "Bar Date"), is hereby established as the last date for filing motions seeking allowance of any Subject Administrative Expense Claims or proofs of claim with respect to any Post-Petition Wages. **THIS IS A BAR DATE**; and it is further

ORDERED AND ADJUDGED that any creditor or party-in-interest seeking allowance of any Subject Administrative Expense Claims must file a motion seeking allowance of such claim and any holder of a claim for Post-Petition Wages must file a proof of claim with the Clerk of the Bankruptcy Court on or before the Bar Date and shall serve such motion or proof of claim upon counsel for the Trustee, Neil C. Gordon at Arnall Golden Gregory LLP, 171 17th Street, NW, Suite 2100, Atlanta, Georgia 30363-1031; and it is further

ORDERED AND ADJUDGED that the Trustee and professionals retained by him in accordance with the Bankruptcy Code **ARE NOT REQUIRED** to file a motion seeking allowance of administrative expense claims incurred in connection with their employment in this case by the Bar Date; and it is further

ORDERED AND ADJUDGED that any creditor or party-in-interest that has been awarded or denied an administrative expense claim by order of the Court **shall not be required to** file a motion by the Bar Date.; and it is further

ORDERED AND NOTICE IS HEREBY GIVEN that, pursuant to the terms and conditions of this Order, any creditor or party-in-interest required to file a motion for payment of any Subject Administrative Expense Claims or a proof of claim for Post-Petition Wages who fails to do so by the Bar Date SHALL BE FOREVER BARRED, ESTOPPED AND ENJOINED FROM ASSERTING SUCH CLAIM OR EXPENSE AGAINST THE DEBTOR, THE ESTATE, AND THE PROPERTY OF THE ESTATE, AND THE ESTATE SHALL BE FOREVER DISCHARGED FROM ANY AND ALL INDEBTEDNESS, LIABILITY OR OBLIGATION WITH RESPECT TO SUCH EXPENSE; and
