Gordon (the “Trustee”) to Employ Auctioneer and Appraiser (the “Application”), having been read and considered, and it appearing to the Court that no notice of a hearing on said Application should be given, a copy of the Application to Employ Auctioneer and Appraiser and the proposed Order, having been served upon the United States Trustee for the Middle District of Georgia, and it further appearing that ROWELL AUCTIONS, INC. (“Rowell”) and ASSET MARKETING SOLUTIONS, LLC (“AMSLLC”) are further engaged in businesses that represents no

adverse interest to the Bankruptcy Estate (the “Estate”) of the Debtor Alpha Protective Services, Inc. (the “Debtor”) in the proceeding upon which they are to be engaged, and that their employment is necessary and would be in the best interest of the Estate of the Debtor, it is hereby

ORDERED that pursuant to 11 U.S.C. §327 and Bankruptcy Rule 2014, the Chapter 7 Trustee is hereby authorized to retain and appoint Rowell as Auctioneer and AMSLLC as Appraiser for the Estate for the purposes and terms specified in the Application. There shall be no actual payment made by the Estate to Rowell or AMSLLC without further Court Order, nor shall any auction be conducted without a separate application to the Court subject to objection after notice. It is further

ORDERED that this Order is entered subject to any objection by the United States Trustee, which objection must be filed with the Clerk and served upon the undersigned Trustee within twenty-one (21) days of the entry of this Order.
