reduce the claim to \$52,976.83 on July 22, 2013; and it appearing, that pursuant to Section 8.10 of the Second Amended Joint Plan of Reorganization confirmed by this Court on April 8, 2013 in the underlying Chapter 11 Case (the "Plan") that the Trustee has the authority to settle and resolve the claims of Spirit without further notice or hearing and that the Trustee represents and warrants that the approval of the Beneficiaries Committee has been obtained for the resolution of the Claim as set forth herein; and it appearing, based upon the signatures of their respective counsel below, that the Trustee and Spirit have agreed to the reduction and allowance of the Claim as set forth herein and, for good cause shown, it is hereby


ORDERED that the Claim is hereby reduced from \$316,031.71 to \$155,000 and that Spirit shall hold an allowed Class 8 Claim under the Plan in the amount of \$155,000 which shall be Spirit's only allowed claim in this case.
