NOTICE OF CONTINUED HEARING

NOTICE IS HEREBY GIVEN, pursuant to Fed. R. Bankr. P. 4001(b)(2), that S. Gregory Hays, Chapter 7 Trustee (the “Trustee”) for the bankruptcy estate of Trade Am International, Inc. (“Debtor”) seeks an order, pursuant to Section 363(c)(2)(B) of the Bankruptcy Code, authorizing the Trustee to use certain insurance proceeds, which *may* constitute the cash collateral of Jupiter IL, LLC (“Jupiter”) and/or Deutsche Bank AG Cayman Islands Branch (“Deutsche Bank”), to pay certain tax claims, as more particularly described in *Trustee’s Motion for Authority to Use Cash Collateral in Order to Pay Certain Tax Claims* [Doc. No. 84] (the “Motion”).

Counsel for the Trustee and counsel for Jupiter and Deutsche Bank appeared at the Hearing. At the Hearing, the Court determined that an evidentiary hearing was needed related to the Motion and that it would consider the Motion at a later date.

PLEASE TAKE FURTHER NOTICE that the Court will also hold a continued hearing on the Motion in **Courtroom 1201 Richard B. Russell Federal Building, 75 Spring Street, S.W., Atlanta, Georgia 30303, at 1:30 p.m. on April 28, 2014 (the “Continued Hearing”).**

Your rights may be affected by the Court’s ruling on the Motion. You should read the Motion carefully and discuss it with your attorney, if you have one in this bankruptcy case. (If you do not have an attorney, you may wish to consult one.). If you do not want the Court to grant the relief sought in the Motion or if you want the Court to consider your views, then you and/or your attorney must attend the Continued Hearing. You may also file a written response to

the Motion with the Clerk at the address stated below, but you are not required to do so. If you file a written response, you must attach a certificate stating when, how and on whom (including addresses) you served the response. Mail or deliver your response so that it is received by the Clerk at least two (2) business days before the Continued Hearing.
